First paragraph in the report explains a situation where an unapproved Examiner assisted in taking 'B' tests. He was advised that he could do the tests by the Area ASC.

PAS Controller requested clarification from Areas Council that the decision he took to negate the tests was the correct action to take.

PAS Controller had unanimous support from Areas Council in the action he took.

Final paragraph in the report suggests it might be prudent to include some additional wording in the Member's Handbook and Achievement Scheme Guidance notes on the use of buddy-leads.

Northern Area proposed the following wording

**Buddy leads and other dual control training aids must not be used during any Achievement Scheme test.**

The additional wording above will be incorporated in both the Achievement Scheme Guidance booklets and the Members Handbook.

A brief debate ensued with regard to obtaining certificates from commercial training schools. The general consensus was that the procedures put in place a few years ago allowing clubs the prerogative to re-test if they felt the club member was not up to standard was working effectively.

**b) Silent Flight**

He has very little to report on as there is not a great deal of activity in testing for Silent Flight, which seems to be the normal.

He asked this Council if there have been any comments from clubs with regard to the satisfaction of the Silent Flight scheme and if there is room for improvement.

The Technical Secretary commented that it might be worthwhile focusing on clubs to try and get them to institute a minimum requirement on the slopes. They are flying in a gradually increasingly busy ground environment and there seems to be very few requirements from slope pilots at club level.

SF Controller responded that in practical terms running slope tests is not as easy as you may think, for several reasons.

SF Controller felt this required further debate and asked permission of the Chairman to include an item on a future agenda.

ASRC would like the agreement of this Council to update the Standards Booklets annually. The meeting were in favour of this but it should be noted that any proposed changes for consideration at the September Area Council meeting should be circulated in plenty of time before the meeting and it would be beholden on everyone to check them properly and comment accordingly.

In the report Areas are invited to give their opinions on the subject of how clubs can be encouraged to promote model building and flying in a manner instead of restricting the age of membership or even closing the door to new members as some clubs do.

Some Areas reported on the work they already do in this respect.

Reference the lack of assistance from local Areas to man the stand at the Association of Science Education event in Reading in January as commented in the first paragraph, London Area responded that they were unaware the event was taking place and that help was required. Had they been made aware they could have arranged from someone to assist.

London Area are very active in trying to promote model flying to schools however it can be very difficult actually getting in and generally is reliant upon one of the teachers being a modeller.

South Midland advised that there is another route in to schools, which is a National scheme called STEM Ambassadors.

He is currently involved in a flight challenge with a local school through that scheme. The school actually receive funding through the scheme.

North West advised that approximately three years ago they placed an advert in BMFA News asking if there were any model flyers who were teachers, who might be interested in running a scheme at schools. They received only 3 responses and from that only 1 actually ran a scheme.

More use could be made of the STEM Ambassadors scheme and a request was made for South Midland to pass on the information to Mike Colling.

### **Gyros**

*It is acceptable to use an electro-mechanical or solid state gyro in any helicopter being used to take the test although electronic stabilisation is restricted to a single sensor acting in rotation around the yaw axis only.*

*This allows a range of gyros to be fitted, from simple yaw dampers to solid state heading lock units but only acting on the tail rotor.*

### **Gyros and Electronic Stabilisation**

*Where a fly bar is fitted, it is acceptable to use an electro-mechanical or solid state gyro in a helicopter being used to take the test although electronic stabilisation is restricted to a single sensor acting in rotation around the yaw axis only. This allows a range of gyros to be fitted, from simple yaw dampers to solid state heading lock units but only acting on the tail rotor.*

*If the helicopter does not have a fly bar fitted it is acceptable to use extra electronic stabilisation, however the extra electronic stabilisation must only be acting as a fly bar replacement system and must not take over control from the pilot or achieve automated flight.*

*The use of any autopilot and/or artificial stability features which are (or may be) designed into such units beyond the definition above is not acceptable during the test and is not allowed. **Candidates should be prepared to explain the capabilities of the system they are using and show that it does not take over control from the pilot and that automated flight will not be achieved during the test.***

Remove

**A pilot capable of flying to 'B' certificate standards and wishing to go straight to the 'B' test without taking the 'A' test may do so but candidates should on no account be forced along this path. A flyer, known within a club to be a good pilot, going through the 'A' before taking the 'B' can be an excellent example to the rest of the club members and this should be pointed out to any candidate wishing to go direct to the 'B'.**

And replace with

**"A candidate wishing to take the 'B' must already have passed the 'A'. A candidate is allowed to take both tests consecutively; this is entirely acceptable. In such a case, it is suggested that all pre-flight checks are completed, followed by the A test manoeuvres. If the examiner is happy with the standard, it is perfectly appropriate to continue with the B test manoeuvres. This would be followed by either A or B questions as required, after the post-flight checks. Refuelling or exchange of electric flight pack is permitted between tests, and also within the tests with the examiners permission.**

## R/C Power Achievement Scheme Controller

Report to Areas Council 29 January 2011

Three B FW tests took place where only one of the examiners was on the BMFA list of approved examiners. I wrote to the candidates to tell them that their tests were not completed in accordance with the directions in the Handbook, and would not therefore be allowed. The examiner concerned apologised for his actions but stated that he had contacted his ASC for advice.

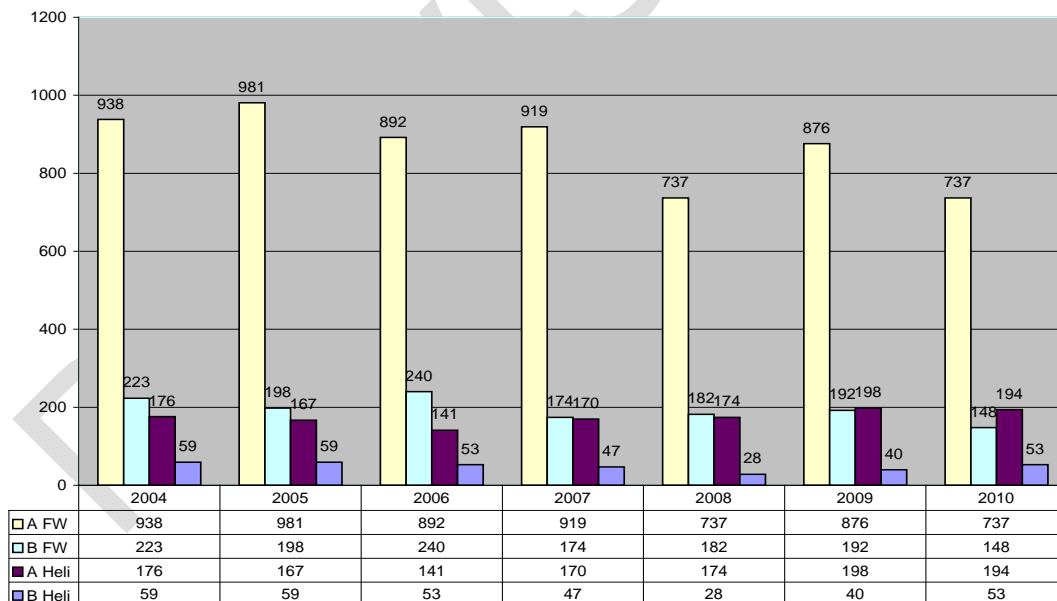
The ASC took the view that there were “exceptional circumstances” and advised the use of the none-BMFA examiner. I told the ASC this was not acceptable.

It seems that some are of the opinion that my decision was wrong. Perhaps this Council would confirm either one way or the other.

It came to my attention that an examiner was taking the A FW achievement scheme tests with the candidates using an RC set with a buddy lead attached. I was present with the area ASC when the examiner was interviewed. The examiner stated that use of the buddy-lead was on the grounds of ensuring the safety of his aircraft....should it become necessary to intervene. He readily accepted that this could not be allowed to continue.

Perhaps we need some additional wording in the Handbook or Test Standards now that the use of buddy-leads is far more widespread than when the booklet was published.

## Education Working Group Report to BMFA Areas Council meeting 29<sup>th</sup> January 2011

For those who attended the Full Council Meeting at the beginning of this month and read the Education report you may remember that I was running the BMFA Education stand at the Association of Science Education's annual meeting held at the University of Reading. You may also remember that in my last report to this Council on 25<sup>th</sup> September last year I requested for volunteers to help man this stand. Unfortunately I had to man the stand on my own for the full three days making it hard to follow up some leads. My impression of the event was that it was far busier this year in the exhibition hall than last year. Next years ASE event will be at the University of Liverpool from the 4<sup>th</sup> to the 7<sup>th</sup> January.

There was a general consensus that with the advance of Academy schools there will be more freedom in the science and D & T curricula, this should help education projects such as ours.

From the early days of the BMFA Education programme it was always agreed that for it to succeed we must recruit the help of individual members and clubs and I am happy to report that for the tenth year the Horsham & District Radio Control Model Club are running Dart building workshops in the local primary school. I understand around 100 Darts will be built over 3 to 4 days. 11 to 15 members of the club are involved in this event. The students gain in having fun building and flying models; the school gains in presenting science and D & T related workshops; the club gains in helping and being part of the local community and the BMFA gains in good publicity, this is a win win situation.

## South Midlands Report to Areas Council Meeting on 29<sup>th</sup> Jan 2011

**Attendance** at the past 5 Area meetings had an average voting strength of 14 or ~24% of the 57 clubs in our Area. However, the Clubs sending a delegate typically represent approximately 30-40% of the total BMFA members in the South Midlands Area.

Prior to our AGM we updated our club contacts email distribution list using BMFA supplied list yet approximately 5 emails addresses were found to be undeliverable and assumed to be incorrect or changed.

We intend to make individual contact with some of the larger clubs in the Area (e.g. St. Albans) who do not currently attend Area Meetings and try to persuade them to send a delegate. Our target is to have up to 20 clubs attending on a regular basis. Whilst we are fortunate to have a good attendance compared to some Areas I feel attendance can and should be increased.

In compiling this report I found a number of discrepancies in the list of Clubs in our Area provided by the BMFA office. We will be asking to get these corrected when the membership renewal season has passed.

**South Midlands Area Committee Officers.** Our Area Delegate of several years, Peter Christy, told us in 2009 of his intention to stand down at our AGM in December 2010. Our new Area Delegate is Duncan McClure from White Horse Club but unfortunately he is unable to attend the first 3 meetings this year. However, we have been able to send a substitute to these meetings.

Our Area Education Officer, Brian Cooper, was going to stand down but I am pleased to report we have persuaded him to continue for 2011 as he does an excellent job for schools and youth organizations.

The position of Area PRO remains vacant, as it has done in recent years. Finding more than one nominee or volunteer for each post is a common problem that results in existing Area Officers being re-elected unopposed. I am trying to think of ways to encourage more clubs to contribute to Area organization and activities and stand for posts. After all it is mostly only for 2 years if they do not wish to serve a second term.

- *Ask not what your Area can do for you, but what can you do for your Area (Sounds familiar doesn't it!)*
