The FAI Delegate asked what advice this Council could give him if this matter is not resolved by the CIAM Plenary Meeting, when they come to make any votes about what Serbia may wish to do in the future regarding hosting championships.

The advice from Council to the FAI Delegate was that if there were any bids to host championships from Serbia he should vigorously object but also provide the reason why we are against it, which is that Serbia had not honoured their responsibilities.

**Page 20**

- **Final paragraph, action for Free Flight to email Free Flight Nationals results as a matter of urgency** – The Free Flight Nationals results were emailed to the relevant people. The Records Officer will ensure the Free Flight Nationals results are received on time in 2010.

The Chairman commented that he would also like to see it recorded in the minutes of the Free Flight Technical Committee that they will ensure the results will be provided immediately after the event. Free Flight advised that they have this in hand.

**Page 21**

- **Half way down the page, FAI Delegate report** – The FAI Delegate provided information that the FAI has appointed a replacement for Max Bishop the Secretary General. The new incumbent is Stephane Desprez who formally takes over from February 1<sup>st</sup> 2010.

**Page 27**

- **Top of page, Computer sub-committee** – London Area pointed out that he could not find any information on the BMFA website regarding applications for FAI Licences. This was noted and the CEO will arrange for something to be included on the website.

Several other issues were raised with regard to the BMFA website as follows:

Although there is now a tab on the top of the page which links to the Agendas and Minutes there are still tabs at the side of the page headed Minutes and Agenda with no information contained therein and could now be obsolete.

BMFA Rule Books are difficult to find on the BMFA website. They are actually listed under resources but it was suggested it might be more useful to include a tab for Rule Books.

We could do with introducing a policy for automatic removal of obsolete information on the website.

The CEO would look into the above comments and arrange for any amendments accordingly. The CEO also commented that if anybody has any issues with the website to let him know because he can only take action if it is brought to his attention.

South Midland commented that overall the general navigation on the BMFA website is not very straightforward.

Scale pointed out with regard to removal of out of date information that it is the responsibility of their webmaster to remove out of date information and not the BMFA webmaster.

- **Second paragraph from the top, comment by the Technical Secretary re disproportionate FAI/CIAM fees for World/Euro Champs that “there is the likelihood that if CIAM are not able to do anything it is inevitable the Championships will move to a four year cycle”** – The Competition Secretary made a point that the above quote is only the opinion of the Technical Secretary and it cannot be taken as read and it is not inevitable that the Championships will move to a four year cycle.

Unfortunately an incorrect version of the attachment to the proposal was submitted for inclusion with the agenda, which he apologised for. Council were provided with amended copies of the document.

The Honorary Treasurer provided some background information in support of the proposal.

A couple of minor corrections were made as follows:

*First heading Principles, last line replace “recipients” with “claimants” ;*

*Third heading Allowable Expenses, second bullet point replace “be using” with “use”.*

One of the main points raised was that there is no provision in the guidelines to help future champions. The Chairman commented that they are only guidelines and not set in stone rules. He considers that it is a very good document for a first attempt and commended them to Council to accept.

The guidelines, including the above corrections were accepted.

The Honorary Treasurer implored Technical Committees to put together a structured proposal for what they would like to use the money for when they do the budgets this Summer, which can then be accepted or otherwise at Full Council in September.

**For Discussion at Full Council Meeting, 9<sup>th</sup> January 2010**  
**Guidelines for use of Training and Excellence Budgets**

**Principles**

1. Training and Excellence (T&E) Budgets for Technical Committees are intended to be used for initiatives to improve the prospects of GB teams winning medals at World and European Championships.
2. This funding is additional to the International Teams budget, and should be used in a way that (a) represents “best value” to the membership (from whom the money originates) and (b) best helps the team members.
3. No team member or official should make any financial gain from T&E money.
4. All claims are paid on receipt of approved BMFA expenses claim forms, with receipts. Under no circumstances will payments be made to anyone other than the claimants.

**Intended Recipients**

The intention of T&E is that the money should be used by the current members of the team, including reserves, and for judges/coaches, where applicable, for that discipline.

**Allowable Expenses**

Out of pocket travel expenses

- Mileage to be paid at half of normal BMFA rates, to cover the cost of petrol only (in this case it is not appropriate for BMFA to make a contribution towards the fixed costs of running a car, as the competitor ultimately benefits from the training).
- All other travel costs should use the lowest available fare (including booking sufficiently in advance to achieve relevant online discounts).
- Consider car sharing where possible.
- Any hotels should be budget style or if in UK B&B may be a cheaper alternative.
- Meals should be “pub meal” or equivalent, not expensive hotel meals.

**Venue hire**

In some cases it may be desirable to hire a venue for either practice sessions or team building events for “Intended Recipients” detailed above. In these cases, the following guidelines should be applied:

- T&E money should not be used to subsidise the cost of a venue that would have been hired anyway for another event.
- “Best value” principles must be applied at all times. Make use of the BMFA Office staff to arrange venues where appropriate, and wherever possible use facilities at Chacksfield House for meetings.

**Guest Speakers / Experts**

It may be beneficial to use the services of subject experts (for example experienced international judges for the relevant event). In this case, it may be necessary to pay for a higher standard of travel or hotel accommodation in order to attract suitably qualified people. Costs should be reasonable, and at the lowest level necessary to achieve the objectives of the event.

**Budgetary Submissions**

Each technical committee should submit a cost forecast and timing schedule for the proposed T&E expenditure for their discipline, showing the nature of the training event(s).

I anticipate that the BMFA Chairman, Chief Executive and myself will attend such meetings to try and move things onto a firm, elected and constitutional footing for the future as quickly as possible.

At the annual meeting with the CAA in December 09, the following issues were discussed.

- (a) The request from 'First Person' that the flying criteria for their models as required by the BMFA are relaxed. This applies to camera equipped models where 'First Person' wants to fly on the camera picture (alone). The CAA stated that they completely supported the BMFA view which is that line of sight must be maintained and a safety pilot with 'buddy box' control was considered to be the person in charge of the model.
- (b) The CAA had increasing concerns about the airworthiness of large gliders (20 – 70kg) especially as these very large gliders generally get flown at aero tow events with the paying public present. As nearly all such very large gliders are composite, factory built this is not easy to implement but BARCS were requested to consider this issue for possible recommendations by the time of the December 2010 meeting with the CAA.

Overall the Hon Secretary's job is greatly eased by the office staff who filter most of the relevant incoming correspondence, and I would like to record my thanks for their continued efforts.

## Technical Secretary's Report

First of all my apologies for not being at the meeting. My last heart procedure was on Tuesday but they've extended my 'no driving ban' from the expected two days to five. However, everything seemed to go well and I look forward to attending future meetings.

The rule books are quite well advanced and most of them will not present problems. However, I've not yet heard from Scale, Space, or Silent Flight and I'm particularly concerned about the latter. Perhaps the delegates might be able to report to this meeting so that some information at least can be passed on to me about rules progress.

I should also remind one or two of the Technical Committees that this Council changed their terms of reference in September to specify that they HAD to appoint a rules officer with specific responsibilities to get rules to me by certain dates. These dates are fast approaching.

I also understand that at least one Tech Committee specifically did not appoint such an officer, contrary to their terms of reference.

I would also like to comment on the proposal from South Midland Area concerning the ASRC.

(1) The ASRC is a sub-committee of Areas Council, set up under the precepts of the SMAE Constitution. As such, full Council has no remit to change the make-up or terms of reference of the ASRC; only Areas Council can do that.

(2) If Full Council wishes to take control of the ASRC and make it an elected body, they must also be prepared to take control of the Achievement Schemes too or the chain of command is broken. I think that this would be unwise, considering the vast strides forward that the schemes have made since Areas Council took responsibility for them.

(3) Many of the 'facts' supplied by the South Midland Area are incorrect, especially concerning the experience of the members of the ASRC. A study of the CVs supplied by the members will show the narrowness of South Midland's information.

(4) South Midlands have the make up of the ASRC completely wrong. Initially, interested parties at Areas Council volunteered to serve on the committee. I volunteered as both Technical Secretary and as the required Full Council member on the committee.

The Chairman of the committee was chosen at its first meeting and membership has been fairly stable since then, with one or two leaving and others being invited to join (including, I should add, the South Midland ASC who is also one of their Chief Examiners).

Also, when the committee is ratified at the first Areas Council meeting of the year, NO POSTS are quoted in the proposal. If anyone other than Terry Rounce wished to be Chairman of ASRC, there would be a vote at its first meeting.

Incidentally, I still serve as the required Full Council member on the committee.

(5) From a personal point of view, I volunteered to take on the obligation of presenting the ASRC's proposals to Areas Council. It's a job I also do for other committees that I sit on. In addition, I think that I resent the implication that I might have 'conflicts of interest'. I don't think that anyone in this room could accuse me of being partisan towards any one discipline or area within model flying and I have never had any problem doing the job attached to the hat I'm wearing at any given time.

I represented the BMFA at the RAeC Council meeting on Oct. 1st; there was little of immediate BMFA relevance, but the following points may be of interest.

- 1) The forthcoming FAI General Conference in Korea may potentially result in several changes in policy. It is seen by the RAeC as important that the airport commissions (such as CIAM) should retain their ability to control their own disciplines; a proposal that members of the Board should not also hold Commission posts could distance the various disciplines from the politics of FAI management. The RAeC strongly opposes plans to hold the World Air Games annually and prefers a four year cycle; the World and Continental Championships are seen as far more important.
- 2) There is progress with the RAeC website up-dating and two possibilities are being considered. However, as with our own website, the need for a proactive editor to target stories and news is vital to make it relevant.
- 3) Bingolotto tickets are now also being sold via Tesco; association members are urged to encourage the purchased of these and an increased income to airports is expected from the programme.
- 4) John Smythe of the BPA is the new chairman of the Medals & Awards Committee.
- 5) The next RAeC Council meeting will be held on Jan. 7<sup>th</sup> at the RAF Museum, Hendon; it will be preceded by the M&A Committee meeting. The Museum has provided generous facilities for the display of RAeC memorabilia, which will give an opportunity to promote the various airports to aviation-minded visitors.

## Education Working Group Report BMFA Council 9<sup>th</sup> Jan 2010

As you know I have sent my permission to be absent as I am on the BMFA Education Stand at the Association of Science Education annual meeting this year held at the Nottingham University. This is the best place to come in to contact with up to 5,000 science educators of all levels. I was also absent from the Society's AGM as I was running the BMFA stand at the D & T Show at the NEC.

It has always been the aim of the Education Working Group to promote model aircraft building and flying as a good educational tool for both Craft Design & Technology and Science.

At the D&T Show we launched the BMFA's new Education model, the SkyDart. The SkyDart is a 53cm (21") wing span radio controlled electric powered training aircraft kit. It has been specifically designed by Flight Line Plans, in collaboration with Micron Radio Control and Sky Hi Products, as an introduction to radio controlled models that can be flown outside on a calm day or inside in a large school hall or gymnasium. Although this model can be made by an individual person, it also lends itself to being built by a group, such as a science or engineering club or youth group and the instructions have been written and the kit made to facilitate this. Adhesives, paint, motor and radio equipment are required to complete this model. Reaction from people attending the D&T Show was quite favourable.

As I am writing this report at the end of December it may be of interest to look at the BMFA Education Programme in terms of kits sold. Total production of education kits produced by Sky Hi Products has reached 223,482 of which 116,941 are BMFA Darts. Kits produced for 2009 was 19,895. This was an increase of 3666 on 2008.

It may be interesting to note that in 2009, 47.4% of all production is sold by the BMFA Office, 46.7% of production went directly to schools, 8.8% of production went directly to youth organisations and the remaining 3.7% to private individuals. Comparing this with 2008 figures the number of kits sold to schools has gone up by nearly 20% whilst the kits sold to youth organisations went down by over 14%. Make of this what you will.
